Gov. Hodges signs GrassRoots CWP Law Reforms!

The GrassRoots Concealed Weapon Permit (CWP) Law Reforms make *your* CWP more useful by letting you legally carry in many more places than you could before. It took us three years, but GrassRoots members stuck to their guns and got our reforms passed. Gov. Hodges signed the GrassRoots CWP reforms into law May 28, 2002. GrassRoots Gets Results for South Carolina CWP Holders!

Besides getting our CWP law reforms passed, GrassRoots was the first to sound the alarm about a 100% increase in CWP fees --- from \$50 to \$100 every 4 years. SLED wanted more money for "Homeland Defense" and the legislature thought they could charge CWP holders for it. Wrong! GrassRoots quickly got the word out. The very evening the tax was added to the budget, GrassRoots members started deluging the legislature with phone calls and faxes protesting the TAX ON SELF DEFENSE. GrassRoots quickly sent out 36,000 pre-printed, addressed post cards to our members for them to send to their legislators saying, "DO NOT TAX SELF-DEFENSE". When those postcards hit the State House like a huge, orange, tidal wave, the TAX ON SELF DEFENSE was quickly killed. It cost us quite a bit to send out those post cards. But it was worth it because ALL CWP holders, including you, will reap the benefit in the years ahead.

GrassRoots started out as a small group of people dedicated to improving the CWP laws in South Carolina. GrassRoots has grown into a 501(c)(4) non-profit corporation that is registered as a lobbyist with the SC Ethics Commission. GrassRoots lobbies the legislature to improve the CWP and gun laws in South Carolina. We've gone from a few concerned citizens to over 5000 dues paying members. GrassRoots is the LARGEST South Carolina PRO-GUN organization. But to do more, we need to be even larger, so please, join us!

GrassRoots' focus is strictly on South Carolina issues for people living, working and visiting here in South Carolina. Laws that restrict where self-defense weapons can be carried only endanger the *good* people of South Carolina. The bad guys still carry their weapons because they don't care what the law says - that's why they are criminals. Only the law abiding are disarmed by such laws. Any law which disarms the good guys just provides easy victims for the bad guys and is an unreasonable law and must be changed. *Help us do that!*

When you look at where virtually all of the mass murders have occurred around this country, you will find they have one thing in common - it was illegal to have a gun there. The criminals were assured of finding disarmed victims courtesy of the government's laws! Must we wait until a slaughter takes preasonable laws that only disarm the law shiding good guys?
